- I. **DESCRIPTION:** Green Haven Correctional Facility is classified as a maximum security correctional facility and is located in Stormville, Dutchess County. This facility is used for the general confinement of males 21 years of age or older; however, males between the ages of 18 and 21 may be placed therein for general confinement purposes, in accordance with Title 7 NYCRR, Part 110. Green Haven Correctional Facility serves as an intake facility, receiving state-ready incarcerated individuals from certain counties. Additionally, Green Haven Correctional Facility sends, receives, and temporarily houses in-transit incarcerated individuals transferring to/from other facilities, or for court appearances, etc.

Green Haven Correctional Facility has a Special Housing Unit (SHU), and a protective custody unit.
- II. **FUNCTIONS:** Green Haven Correctional Facility offers academic education; vocational training, and college programming; Alcohol and Substance Abuse Treatment (ASAT); Aggression Replacement Training (ART); industrial training; counseling; volunteer services; transitional services; which includes "Thinking for a Change" (T4C), Family Reunion Program (FRP), Puppies Behind Bars (PBB), and a Correctional Industries furniture/upholstery/textile program.

Green Haven Correctional Facility serves as a Residential Treatment Facility (RTF).

Green Haven Correctional Facility also operates an Intermediate Care Program (ICP), a Transitional Intermediate Care Program (TrICP), and a Step Down to Community from SHU Program.

Green Haven Correctional Facility is classified as Mental Health Service Level 1, as defined in Correction Law, Section 2 (27), with a Residential Crisis Treatment Program (RCTP) consisting of observation cells and dorm beds.
- III. **CRITERIA:** Incarcerated individuals of any security classification are eligible for placement at Green Haven Correctional Facility.
- IV. **PHYSICAL ENVIRONMENT:** Housing units at Green Haven Correctional Facility consist of single cells for incarcerated individuals in general confinement, protective custody, and special housing cells, as well as multiple occupancy rooms, and a dormitory for the ICP.
