- I. DESCRIPTION:** Mohawk Correctional Facility is classified as a medium security correctional facility and is located in the City of Rome in Oneida County. This facility is used for the general confinement of males 18 years of age or older.
- Mohawk Correctional Facility also has a special housing unit.
- II. FUNCTIONS:** Mohawk Correctional Facility offers vocational training, academic education, counseling, transitional services, volunteer services, Sex Offender Counseling and Treatment Program (SOCTP), Aggression Replacement Training (ART), and Alcohol and Substance Abuse Treatment programs (ASAT).
- Mohawk Correctional Facility is classified as Mental Health Services Level 2, as defined in Correction Law, Section 2 (28).
- Mohawk Correctional Facility has the maximum security Walsh Regional Medical Unit (RMU).
- Walsh Regional Medical Unit provides long term care for inmates who require more resources than are available in an infirmary, but who do not require acute care hospitalization. Walsh RMU also provides on-site physician specialty consultation services for the Oneida, Watertown, and Elmira Hubs. Walsh RMU also offers programming in the following areas: ASAT, general business, academic education, ART, SOCTP, and transitional services.
- Walsh RMU is classified as Mental Health Services Level 1, as defined in Correction Law, Section 2 (27). The regional medical unit also functions as a Residential Treatment Facility.
- Mohawk Correctional Facility also has the Department's Food Production Center on its grounds. The Food Production Center is a USDA/Kosher certified food processing center. The Food Production Center provides food items to all of the Department's facilities. Inmates employed at the Food Production Center learn marketable skills which better prepare them for successful reintegration into society and the workforce.
- III. CRITERIA:** To be eligible for placement in general confinement, an inmate must be designated medium security or less.
- Inmates of any security classification are eligible for placement at Walsh Regional Medical Unit.
- IV. PHYSICAL ENVIRONMENT:** Housing units at Mohawk Correctional Facility consist of dormitories, cubicles and rooms in general population. The special housing unit consists of single cells.
- Housing at Walsh Regional Medical Unit consists of four-bed wards, semi-private, private, and secure rooms.
