

Notice to Family and Friends of New York State Incarcerated Individuals

The New York State Department of Corrections and Community Supervision is pleased to announce that the new electronic inmate Trust Account Services system is now available to all inmates statewide.

The enhanced inmate Trust Account Services system expands existing services in state prisons and improves the re-entry process for individuals returning to their communities.

Through the use of current technology, JPay, a national correctional services provider, is providing improved services for the transfer of money to inmate trust accounts. By implementing JPay's system statewide, DOCCS has reduced the duration of time between the deposit of funds and the availability for use by the incarcerated individual, and provide family and friends a greater variety of options to easily deposit money. The new inmate Trust Account Services system also provides individuals released to the community a debit card with the remaining balance from their inmate account, which will give them a foundation to establish a bank account

Under the new system, JPay will continue to offer the existing mechanisms for depositing money into an incarcerated individual's account, without fees, through the conventional visitor deposit lockbox located at each DOCCS facility, or by a money order or check being mailed to the JPay Lockbox address. The new electronic service also provides family and friends the convenience of depositing money by telephone, internet or mobile app; however, there are fees associated with these methods. In addition, JPay partners with MoneyGram offering yet another means to deposit funds, even cash (also subject to fees).

Regardless of which deposit option is selected neither New York State nor the Department of Corrections and Community Supervision receive any fees or commission for these services.

Visit Day Fund Deposits

Visitors will continue to be able to leave cash, money orders and checks at the facility with no fees and only one minor change. Money orders and checks will require the use of a facility provided JPay deposit slip, which will be sent by DOCCS directly to JPay for processing. Cash deposits will be processed as customary by DOCCS facility staff.

In addition to the conventional visit day deposit outlined above, JPay offers five (5) ways to deposit funds:
