PAROLE IS DENIED AFTER A REVIEW OF THE RECORD AND INTERVIEW. THE PANEL HAS DETERMINED THAT YOUR RELEASE, AT THIS TIME, WOULD BE INCOMPATIBLE WITH THE WELFARE OF SOCIETY AND WOULD SO DEPRECATE THE SERIOUS NATURE OF THE CRIME AS TO UNDERMINE RESPECT FOR THE LAW. THE BOARD HAS CONSIDERED YOUR INSTITUTIONAL ADJUSTMENT AND EFFORTS AT REHABILITATION, WHICH INCLUDE YOUR PROGRAM COMPLETIONS, PARTICIPATION IN THE YOUTH ASSISTANCE PROGRAM, VOCATIONAL AND WORK ASSIGNMENTS. THE BOARD HAS ALSO CONSIDERED YOUR CRIMINOGENIC NEEDS. MORE COMPELLING, HOWEVER, IS THE EXTREME VIOLENCE, CALLOUSNESS AND ANTI-SOCIAL BEHAVIOR YOU EXHIBITED WHEN YOU KILLED TWO PEOPLE LESS THAN ONE MONTH APART. THE FIRST MURDER INVOLVED YOU KILLING A FEMALE VICTIM, REDACTED, AFTER YOU SHOT HER IN THE CHEST. DURING YOUR INTERVIEW TODAY, YOU ATTEMPTED TO JUSTIFY YOUR ACTIONS BY TRANSFERRING RESPONSIBILITY TO THE VICTIM FOR HER FAILURE TO PAY DRUG MONEY THAT SHE OWED YOU. THE SECOND MURDER INVOLVED YOU AND YOUR CO-DEFENDANTS ASSASSINATING A 22 YEAR OLD POLICE OFFICER, EDWARD BYRNE, WHO SAT IN A MARKED POLICE VEHICLE IN UNIFORM. OFFICER BYRNE WAS BRAVELY PROTECTING AND SERVING THE COMMUNITY BY SAFE-GUARDING A WITNESS WHO WAS WORKING WITH THE NYPD TO ERADICATE THE BRAZEN DRUG SALES IN HIS NEIGHBORHOOD. YOU AND YOUR CO-DEFENDANTS, ACTING ON THE PERSONAL ORDERS OF A DRUG LEADER, PAPPY MASON, DELIBERATELY AND VICIOUSLY SINGLED OUT A POLICE OFFICER TO RETALIATE FOR PAPPY'S IMPRISONMENT AND TO SEND A MESSAGE. OFFICER BYRNE WAS SHOT IN THE HEAD BY YOUR CO-DEFENDANT MULTIPLE TIMES AT CLOSE RANGE WHILE YOU DISTRACTED OFFICER BYRNE. AFTER HE WAS KILLED, YOU LAUGHED AND BRAGGED ABOUT THE CRIME, WHICH SHOWS A SERIOUS LACK OF REMORSE AND LEVEL OF COLDNESS. DURING THE INTERVIEW, YOU MINIMIZED YOUR ROLE IN THE MURDER AND EXHIBITED LITTLE INSIGHT INTO THIS SHOCKING CRIME. WHILE INCARCERATED, YOU INCURRED MULTIPLE TIER III DISCIPLINARY INFRACTIONS, WHICH INCLUDES THREATS AND A WEAPON. MOREOVER, YOU DID NOT PRESENT A SATISFACTORY RELEASE PLAN. YOUR HEINOUS ACTIONS CONTINUE TO CAUSE INNATE PAIN TO THE BYRNE FAMILY, STILL AFFECTS THE ENTIRE LAW ENFORCEMENT COMMUNITY AND VITIATES THE VERY FOUNDATION OF OUR SOCIETY AND SANCTITY OF THE LAW.
