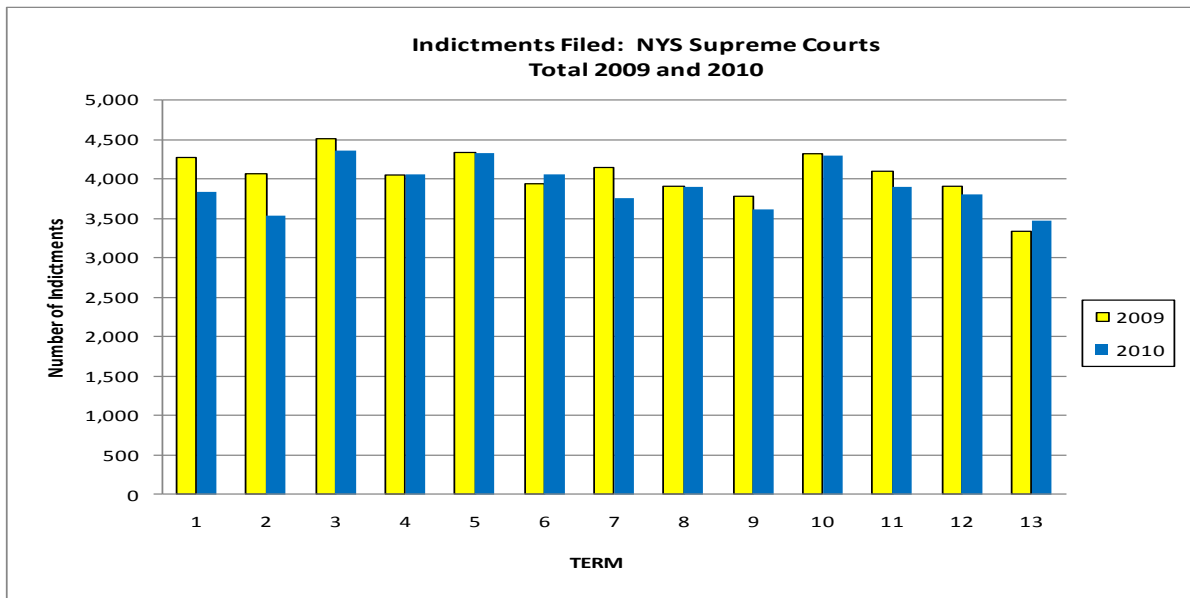
**Indictments, Felony Dispositions, and Pending Felonies
 New York State: The Thirteen Judicial Terms of 2010
 (Based on the Office of Court Administration Caseload Activity Report)**

INDICTMENTS: The total number of indictments for the thirteen terms of 2010 decreased 3% (or -1,752 cases) compared to the thirteen terms of 2009. This decrease occurred in New York City, down 4% (or -882 cases), the Upstate, Other region, down 4% (or -790 cases) and in the Suburban New York City region, down 1% (or -80 cases).

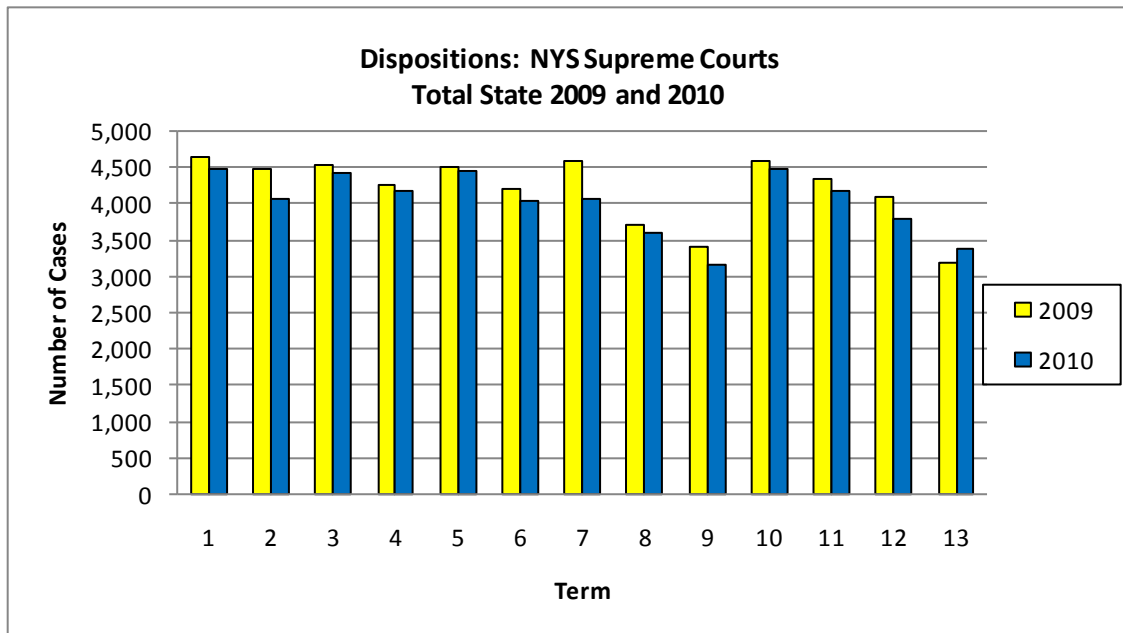

FELONY DISPOSITIONS: At the end of New York State’s thirteen judicial terms in 2010, overall felony dispositions were down 4% (or -2,256 cases) compared to the thirteen terms in 2009. New York City decreased 6%, (or -1,625 cases) and the Upstate, Other region decreased 4% (or -904 cases). Suburban New York City increased by 3% (or +273 cases).

PENDING FELONY CASES: The total number of New York State pending felony cases awaiting disposition rose 1% (or +138 cases) from 19,713 at the close of the thirteen terms in 2009 to 19,851 at the close of the thirteen terms in 2010. This rise occurred in the Upstate, Other region, up 2% (or +61 cases) and in New York City, up 1% (or +86 cases). Suburban New York City decreased by 1% (or -9 cases).

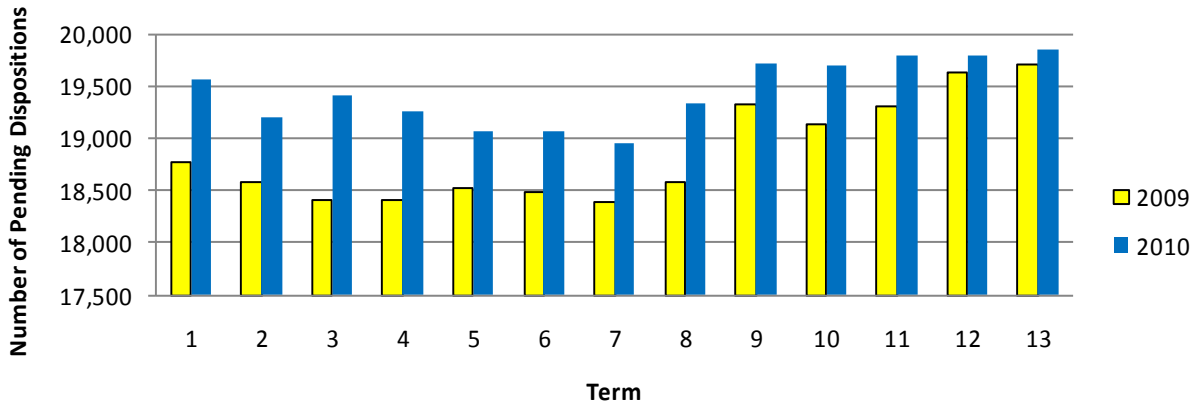

PENDING FELONY CASES (6 months or more): The total number of felony dispositions pending for six months or more rose 5% (or +460 cases) from 8,720 at the close of the thirteen terms in 2009 to 9,180 at the close of the thirteen terms in 2010. This increase occurred in New York City, up 5% (or +381 cases), Suburban New York City region, up 4% (or +13 cases) and the Upstate, Other region up 13% (or +66 cases). These long term pending dispositions tend to be more serious crimes.

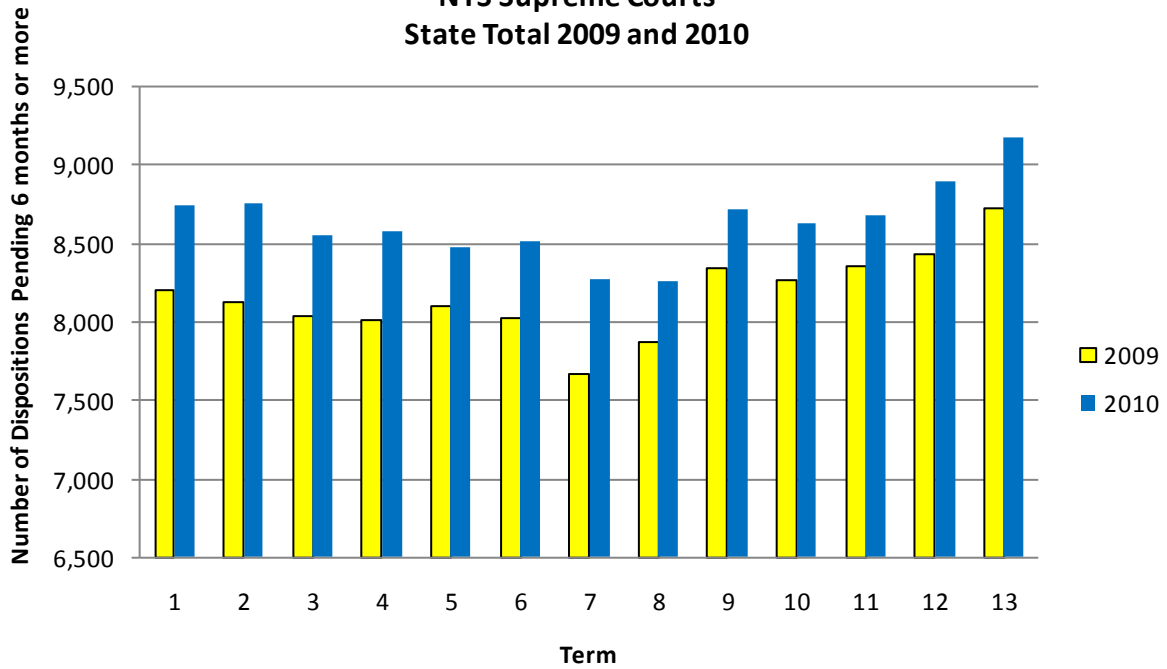

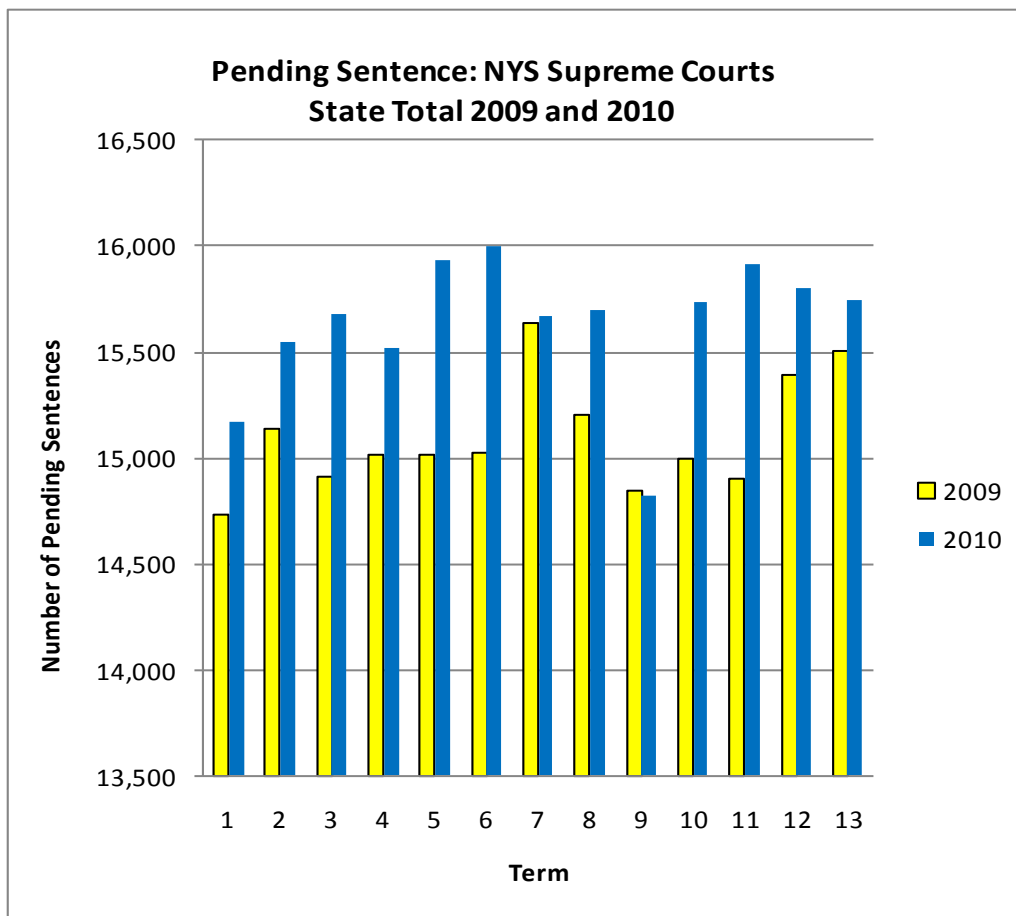

PENDING SENTENCE CASES: The number of offenders convicted, but still awaiting sentence increased 2% (or +247 cases) from 15,501 at the close of the thirteen terms in 2009 to 15,748 at the close of the thirteen terms in 2010. The New York City region decreased by 1% (or -75 cases) and the Rest of the State increased 4% (or +322 cases).
