**ADMISSIONS AND RELEASES
CALENDAR YEAR 2013
(Preliminary Data¹)**

INMATE POPULATION The inmate population in DOCCS facilities dropped by 670 inmates (-1.2%) from the end of 2012 to the end of 2013. The number of state ready inmates stood at 448 at the close of 2013, compared to 265 at the close of 2012, up 183 (+69.1%).

INCARCERATED PAROLEE POPULATION The incarcerated parolee population in DOCCS facilities decreased by 53 parolees (-8.4%) from the end of 2012 to the end of 2013. The number of state ready parolees stood at 15 at the close of 2013, down 3 from the previous year.

INMATE ADMISSIONS Total inmate admissions for CY 2013 at 23,317 were 1.8% or 421 below the 23,738 recorded during this period in 2012. Court commitments decreased by 397 (-2.8%) from 14,089 to 13,692. Technical violators decreased by 131 (-1.8%). There were 1,940 participants admitted to an Alternative treatment program in 2013, up 135 (+7.5%) from 2012. Other admissions decreased by 28 (-7.3%).

INCARCERATED PAROLEE ADMISSIONS Total incarcerated parolee admissions for CY 2013 at 2,701 were 0.6% or 16 above the 2,685 recorded during this period in 2012. Willard Judicially Sanctioned (JS) admissions decreased by 14 (-2.5%) from 2012. Willard violator (PV) diversions decreased by 78 (-7.1%). There were 555 participants admitted to Edgecombe Residential Treatment in 2013, down 81 (-12.7%) from 2012. There were 586 participants admitted to the Parole Diversion Program during CY 2013 (this program began at Orleans in February 2012 and at Hudson in November 2012). As expected, this was a substantial increase over the comparable period in 2012.

INMATE RELEASES There were 23,989 inmates released from DOCCS facilities during CY 2013, which were 946 fewer (-3.8%) than the 24,935 released during this period in 2012. Parole releases accounted for 8,045 of the CY 2013 releases compared to 8,335 in 2012, down 290 (-3.5%). Conditional releases at 9,910 were 4.0% below the 10,326 in 2012 (-416 conditional releases), while releases at maximum expiration of sentence decreased by 158 (-5.9%). There were 1,833 cases released following participation in the Alternative treatment program, up 3 (+0.2%) from 2012. Maximum expiration of sentences with post-release supervision decreased by 59 (-5.1%) compared to the prior year. Other releases decreased from 589 to 563 (-4.4%).

INCARCERATED PAROLEE RELEASES There were 2,739 incarcerated parolees released from DOCCS facilities during CY 2013, which were 132 more (+5.1%) than the 2,607 released in 2012. Willard Judicially Sanctioned releases accounted for 537 of the CY 2013 releases compared to 553 in 2012, down 16 (-2.9%). The number of Willard violator diversion releases at 1,023 were 75 below the 1,098 in 2012 (-6.8%). The number of parolee participants released from Edgecombe Residential Treatment decreased by 84 (-13.1%). There were 624 parolee participants released from the Parole Diversion Program during 2013 (this program began at Orleans in February 2012 and at Hudson in November 2012).
